

THE VILLAGE OF MAYO

BY-LAW #188

A By-law to establish an emergency plan and a Civil Emergency Measures Commission and appoint the members thereof.

WHEREAS, Section 265 (a) of the Municipal Act provides that Council may pass by-laws for municipal purposes respecting amongst others emergency services and other emergencies; and

WHEREAS, Section 235 of the Municipal Act states that despite any other section in this Act, a council of a municipality may take such temporary measures necessary, within its jurisdiction, to respond and deal with an emergency, and

WHEREAS, Section 5 of the Emergency Measures Act and Section 192 (1) of the Municipal Act provides that subject to the provisions of the Civil Emergency Measures Act, Council shall by by-law establish a civil emergency measures commission and appoint its members; and

WHEREAS Section 192 (2) of the Municipal Act provides that Council may appoint a civil emergency coordinator who shall carry out the instructions of the commission, and

WHEREAS Section 192 (3) of the Municipal Act provides that Council may empower the commission to incur liabilities within the amounts included therefor in the annual budget,

NOW THEREFORE, the Council for the Village of Mayo in open meeting assembled **HEREBY ENACTS AS FOLLOWS**:

1. This by-law may be cited as **"The Village of Mayo Emergency Measures By-law"**.
2. Schedule "A" attached hereto and forming part of this by-law shall be the Emergency Plan for the Village of Mayo.
3. An Emergency Measures Commission is hereby appointed and the members shall be:

Chair: Member of Council, Village of Mayo

Coordinator: Chief Administrative Officer, Village of Mayo

Deputy Coordinator: Foreman of Protective Services, Village of Mayo

Engineering: Foreman, YTG Highways
Foreman of Environmental Health, Village of Mayo
Fire Chief, Village of Mayo
Resource Management Officer (Forest Fire)

Mayo RCMP: NCO i/c, RCMP Mayo Detachment

Medical/Welfare: Nurse in Charge, Mayo Nursing Station
Supervisor, YTG Ambulance Services
Social Worker, YTG Human Resources

Environmental
Protection: Conservation Officer, YTG Renewable Resources


Support Services: Sergeant, Mayo Rangers
Member, Mayo Search and Rescue
Senior Serviceman, Yukon Energy Corporation
Senior Serviceman, NorthwesTel


This by-law shall come into full force and effect upon the final passing thereof.
