## The Village of Mayo By-law No. 97-154

#### A Bylaw to alter the boundary of the Village of Mayo

**WHEREAS**, Section 14 of the Municipal Act, Chapter 119, of the Yukon Territory provides that the Council of a municipality may by bylaw submit to the Executive Council Member a proposal for the alteration of the boundaries of the municipality; and

**WHEREAS**, the Council for the Village of Mayo would like to expand their present boundaries to include the area along the Silver Trail Highway up to and including the Mayo Airport to provide industrial land for development which presently does not exist within the present Village of Mayo boundaries; and

**WHEREAS**, the Council for the Village of Mayo would also like to expand their boundaries to include the Stewart River Dike from Binet Avenue the Mayo River Dike, to obtain jurisdiction over the waterfront area; and

**WHEREAS**, the Council for the Village of Mayo would like to increase the number of electors and prospective Council members by expanding the Village boundaries to the Mayo Airport; and


**WHEREAS**, the Council for the Village of Mayo has sent out a referendum to the residents of the area of the proposed boundary expansion, and has had a favourable response from the majority of those residents; and

**WHEREAS** the Council for the Village of Mayo has informed the residents in the proposed boundary expansion area that their tax rate would remain the same, and that future tax rates would be linked to additional services, as requested by the residents, and that bylaws that are currently in place within Village of Mayo boundaries would be reviewed to see if they would be applicable or need to be amended for the residents of the proposed boundary expansion area.

**NOW THEREFORE**, the Council for the Village of Mayo in open meeting assembled hereby **ENACTS AS FOLLOWS**:

- 1. This by-law may be cited as the "Municipal Boundary Expansion Bylaw".
- 2. The Council for the Village of Mayo proposes and asks that the Commissioner in Executive Council alter the boundary of the Village of Mayo as proposed per the attached Schedule A attached to and forming part of this bylaw.
- 3. This bylaw shall come into full force and effect upon the final passing thereof.
