## a) Mayor's Report

### Landfill / Two Garbage Trucks

Mayor Bolton found 2 Garbage trucks on Kijiji. Village Council had previously discussed purchasing a garbage truck for hauling household waste from inside municipal boundaries. Council discussed the pros and cons of such a purchase. Council agreed that they would like to purchase both garbage trucks due to the list price being affordable and having a backup truck ready to go when the first truck needs repairs. Council also discussed the landfill and that YG now would like municipalities to sign leases for the YG Land that the landfills that are operated by municipalities are on. Councilor Andre gave an up-date on Landfill discussions from the last AYC board meeting. Mayor Bolton and Councilor Andre are planning to attend the next board meeting in February.

the Village of Mayo Council discussed providing household garbage pickup to its citizens, to reduce the need for citizens to take their own garbage to the Mayo Landfill, and the Village of Mayo has been researching the cost and availability of garbage truck(s), and

Mayor Bolton found 2 used 2009 Freightliner garbage trucks with Cummins engines on Kijiji, with low mileage and at an affordable

price, and

Whereas

Mayor Bolton contacted the seller, Driveline Truck & Trailer Inc. in Summerside, PE, and the 2 trucks are available for \$39,500 each, and could be delivered to Mayo, Yukon, for an additional cost of \$7,000, and

Whereas

the seller also offered emission ECM tune on the trucks for \$3,500 each and to fully service the engines, transmissions and hydraulic fluids with a lighter oil for the extreme weather in Mayo for \$1,500 each truck, now therefore

Be it resolved

that

the Council for the Village of Mayo discussed this and believes this to be a good opportunity, to purchase two garbage trucks, to have one as a backup truck if the other truck needs repairs, and

Be it further resolved that

the Village of Mayo Council agrees to purchase the two trucks listed above, in the amount of \$39,500 each, plus the cost of mechanical and winterizing both trucks for \$10,000, plus \$7,000 for delivery of both trucks to Mayo, and

Be it further resolved that

the amount of \$96,000 plus tax will be coded to the capital budget's public works equipment code, and that a down payment of \$20,000 will be provided to the seller upon provision of the Bill of Sale, and that be balance will be paid upon delivery of the two garbage trucks to Mayo.

## CAO Report of Wednesday December 19, 2019

### a) Reminder - change of Council meeting date

Due to the School Christmas Concert being held on Wednesday, December 18, 2019, Council has agreed to hold their regular Council meeting on Thursday, December 19, 2019. For Council's information.

### b) Wildland Fire Management Plan Meeting

The venue has changed for the Wildland Fire Management Plan meeting. It will now be held in the Mayo Curling Lounge on December 18, 2019 from 1:30 to 3:30 pm. For Council's information. Councilor Andre and the CAO attended. The Public Works Manager was not able to attend due to an urgent issue elsewhere. Councilor Andre gave an update about the meeting. YG is looking to form a committee, which would include member(s) from VOM and NND.

The CAO suggested that committee should have a member from Administration and from Council. Councilor Andre volunteered to take this on if no other Councilor is interested. Council asked that Scott Hamilton be involved in some capacity.

#### c) Land Application for subdivision of lands

YG lot east of NND's Youth Center on Duncan Avenue is scheduled to be subdivided into two lots. For Council's review and comments.

Council is pleased YG is working towards making more lots available for future development by the public. Council discussed that YHC had two houses for sale on First Avenue that they had put out of commission years ago. Councilor Andre mentioned that he was aware that several people had put bids in on these properties. Recently there was interest in these two properties. The Village had not been aware of these two properties being up for bid. There were for sale signs on the fences of these properties, but YHC had not contacted the Village to make them aware of a new tender being out for these properties. Council also heard that there is no build requirement on the sale of these lots, since there are buildings on these lots. Council would like to discuss this with YHC, and that the Village of Mayo should be informed when properties in Mayo go up for sale. Council also commented that build requirements should be put on the sale of new properties.

We received the template for partner action and other information from Aletta Leitch. Council is asked to review this information prior to the January 8, 2020 Council meeting that Aletta is planning to attend. For Council's information and consideration.
