6. a) Mayor's Report

Mayor Bolton gave Council a brief update about the WCB meeting that was held in Mayo on December 2, which he and the CAO attended.

There was concern about the road from Mayo to Stewart. It had not been cleared properly after one of the recent heavy snowfalls.

a) Provisional O&M budget for 2020

Council mentioned that the telephone expense for the Staff house is high. They would like to bring the cost down for this code.

b) Mayo Health Centre

We received a reply from Minister Frost to Council's letter regarding staffing at the Mayo Health Centre. For Council's information.

Councilor Andre stated that he has spoken to the Nurse Practitioner and reports that she is happy in Mayo. Council is still concerned that the Nurse Practitioner position in Mayo is on a trial basis and that the position will be evaluated in 2020. Council would like to take part in the evaluation of this position. A letter will be sent to YG H&SS stating this.

c) Commercial Driver Medical Requirement

We received a reply from Minister Mostyn to the Village of Mayo's letter regarding the changes that came into effect on November 4, 2019. For Council's information.

Council is still not 100% clear on what the new regulations are, as there is different information in different places. Mayor Bolton has been asked to comment on this issue by local media and has declined. The Mayor is going to look into this further and get back to Council.
