6. a) Mayor's Report

Mayor Bolton spoke with YG officials (Minister Currie Dixon and Jennifer McGillivray) during the AYC AGM last weekend in Watson Lake, regarding VOM's plans to build a new Fire Hall. He was told that the Village of Mayo needs to submit a conceptual drawing. It was decided that the location of the building will be the empty lot across from the Pumphouse, and YG will start the process of transferring ownership to VOM.

Councillor Ellis asked if there is any movement on the next phase of water/sewer work. Mayor Bolton said we are still waiting to hear from the Federal Government about funding for this project.

Regarding transfer of the Landfill operation to YG, Mayor Bolton said that he found out that the permit can be transferred to YG, and that this would not require a new YESAB assessment.

CAO Report of Wednesday May 18, 2016

b) Official Community Plan (OCP) Open House

The Village's open house to receive input and hear comments from the public is scheduled for Wednesday, May 18, 2016 from 6 - 7:30 pm at the Village of Mayo Council Chambers. We have put out a notice about the upcoming open house on local bulletin boards as well as on

our website. The draft OCP was made available on the Village of Mayo website and as a paper document for pickup at the Village Office. For Council's information.

Mayor Bolton, Councilor Andre, Clerk/Treasurer Barb Barchen and Administrative Assistant Taylor Ewing were present for the Village of Mayo Open House to hear comments from the public regarding the draft 2016 Official Community Plan. No one from the public attended the open house to provide comments on the draft OCP.

c) Possible first reading of OCP bylaw

Following the OCP Open House, Council will be able to discuss the comments received from the public. Council will be able to proceed to first reading of the OCP bylaw. Any comments received at the open house can be added to the OCP prior to second reading of the bylaw. For Council's information.

d) YG Rural Land Development

YESAB has organized a public meeting regarding YG's land development 4 km north of Mayo. The meeting will be held on May 25, 2016, from 7-9 pm at Curling Lounge. We received an email from Jim Tredger stating that he brought this proposed development up in the legislature. The First Nation of Na-Cho Nyak Dun was informed by YG of the proposed development and it was discussed during public Council meetings on several occasions.

Jim Tredger would like to hear Council's thoughts/suggestions on this issue. For Council's review and discussion.

Council was concerned about some apparent inaccuracies in the information presented to the Legislature by MLA Tredger regarding opposition to the proposed land development. Mayor Bolton will contact Jim Tredger to clarify the situation. Councilors Ellis and Ewing are planning to attend the YESAB public meeting.

e) Housing Action Plan for Yukon

We received an email from the Yukon Housing Corporation (YHC) informing us of a Housing Forum that is scheduled to be held on June 16, 2016. YHC is also sending a Housing Action Plan Communication Survey to stakeholders for review and completion. For Council's information.

f) Amended Yukon recycling regulations

We received a News Release from YG pertaining to the new recycling regulations, and an email from Dwayne Muckosky answering questions about the new regulations. For Council's information.

g) Future Water & Sewer Upgrades

We received an email from Rick Kent pertaining to future phase construction. He would like to know if Village of Mayo would like YG Infrastructure Branch to do the majority of the work (design, tender, construction & warranty) with additional input from Village of Mayo, or if the Village would like to run the entire project. For Council's information and discussion. Council would like to appoint one VOM Public Works employee to work in coordination with the YG Project Manager (Rick Kent). Scott Hamilton said Rick Kent will be coming to Mayo soon to look for deficiencies on both the Pumphouse and Water/Sewer projects before signing off on the

We have been made aware that the teacher of the Yukon College Heavy Equipment Technician Program who has been in Mayo to teach the course for the past 6 months, lost his house to the fire in Ft. McMurray. For Council's consideration of providing a donation.

Council would like to give a \$500 donation to the Red Cross for Fort McMurray fire relief.
