6. a) Mayor's Report

Mayor Bolton informed Council of the conference call with Minister Streicker and Dr. Hanley that he and the CAO attended prior to this meeting. During the call it was stated that the border with BC will be closed to the general public again. Anyone traveling from BC to Yukon, except essential workers, will have to self-isolate for 14 days.

Mayor Bolton also mentioned that he will contact Minister Streicker and the Premier regarding the lack of sufficient banking services in the community.

b) Administration

CAO Report of Wednesday November 18, 2020

a) Joint Council meeting

We have now finalized a Joint Council meeting for Monday, November 16, 2020 at 7 pm in the Mayo Community Hall. Meeting packages will be given out on Monday. We will set up the hall with social distancing in mind, have masks available, and hand sanitizer. For Council's information. Council stated that the Joint Council meeting went well.

b) Energy Retrofit

We received information from Ben YuSchott about YG's proposed program, as well as the copy of a letter from the City of Whitehorse, and a draft letter from AYC that President Curran wants to hold off on sending until after the AYC Board meeting in December. For Council's discussion. Council discussed this proposed program and reiterated their previous comments that this program will be to cumbersome for municipalities to administer, because municipalities are not collection agencies.

c) MMIWG Strategy

We received an email from the YG Women's Directorate about the Yukon Strategy on missing and murdered indigenous women, girls, and two-spirit+ people. YG is planning to unveil this strategy on December 10, 2020. In a letter addressed to Mayor Bolton they ask the Village of Mayo Council to confirm their willingness to sign the renewed 2020 Declaration by November 20, 2020, and/or consider hosting a gathering in Mayo to help create awareness, to ensure that families and survivors of MMIWG2S+ remain at the heart of this work and to encourage community members to sign the 2020 Declaration and the Strategy. For Council's consideration.

d) YG-VoM Fire Protection MOU

The MOU with YG Emergency Response/Fire Safety Inspections & Investigations was recently mentioned by another community. We have not discussed this draft MOU with the FMO since last January. For Council's review and discussion.

Council tabled the draft MOU to the December 2nd meeting for another review.

e) Extending Yukon's State of Emergency

A tentative zoom meeting has been scheduled for November 18, 2020 from 5:45 to 6:45 pm, for Mayor's, and CAO's to hear from Minister Streicker and Dr. Brendan Hanley about extending the state of emergency. For Council's information. Dealt with previously.

f) Draft Rental Agreement

I have attached the draft rental agreement with the new rental fee for the banking space in the new Fire Hall. For Council's information and consideration.

Council reviewed and discussed the proposed rental fee which is based on the lower cost of the range of rental fees per square foot in Whitehorse with a further reduction of 25% to acknowledge YG's contribution to the new building and office space.

g) AYC Board meeting

Attached are some agenda items for the December 5, 2020 AYC Board meeting for Council's information and discussion.

Council discussed the proposed sale of the AYC condo. Council stated that things may go back to needing the office and meeting space once the pandemic is over, or if there is a staff change in the future. Therefore, Council is not in favor of the sale of the AYC condo at this time.

Council tabled the discussion of the AYC Strategic Plan to the December 2nd Council meeting.

h) Christmas Bonus

Council has in the past provided a Christmas Bonus to full time staff and Rec. Board members. Since there are only a few weeks left until Christmas, Council was asked for their consideration to provide the annual Christmas Bonus.
