 - i) CAO Report of Wednesday October 16, 2019

a) Annual Fall Community Garage Sale

We've obtained input from the Village's Recreation Coordinator regarding Council's suggestion to forward the proceeds from table rentals from the Community Garage Sale to Soccer Club. Ian agreed that this would be a good group to be the recipient of the table rental proceeds. For Council's final approval.

Council agreed to donate the money to the Mayo Soccer Club.

b) Review of Health and Social Services

An independent review panel has scheduled a meeting with Council for October 21, 2019 at 7 pm in Village of Mayo Council Chambers to discuss the upcoming review of YG's Health and Social Services. They are also planning a public meeting on October 24, 2019 at noon at NND Government House. For Council's information.

c) Joint Council meeting

We've scheduled a Joint Council meeting for October 17, 2019 at 7 pm in Village of Mayo Council Chambers. There will be a presentation about the Culture and Tourism Strategy during this meeting. The Agenda and meeting package will be handed out prior to the meeting. For Council's information.

d) Mineral Development Strategy

YG is starting to work on a Mineral Development Strategy. We've been contacted by Michael Pealow. YG would like to receive input from municipalities prior to staring the process. They would like to know:

- 1) How would you like to be engaged in the YMDS process?
 - Council would like to see meetings in the community and attend the public meeting.
- 2) What are the things we need to think about and talk about when considering the future of mineral development in the Yukon?
 - Council will think about this in preparation for the meeting in the community.
- 3) What are the elements we should consider when designing an effective process?

 Council finds the "Engage Yukon" site not to be very user friendly. Not everyone has a computer and is able to access the survey. The entire survey should be printable from the engage yukon site, rather than having to call for a paper copy, especially if the answers should come from Council as a whole rather than individual Councilors.

Mayor Bolton also noted that the new regulations around Driver Medicals is not favorable for those living in communities. There is not always a Doctor in Mayo to perform the Medical. The Mayo Volunteer Fire Department would be affected if they lost even one driver. The CAO will draft a letter on behalf of Council.

e) Animal Control

As per Council's directions, we've put out a posting for an Animal Control Officer. No one applied by the closing date of the posting. For Council's information.

f) Remembrance Day

There will be a Remembrance Day ceremony in the Mayo Community Hall on November 11, 2019. Will Mayor Bolton be available to lay a wreath on behalf of the Village of Mayo? Mayor Bolton will not be available. Deputy Mayor, Trevor Ellis, will lay a wreath on behalf of the municipality.

The CAO also notes that the Legion is having a flag raising ceremony at the Legion area in the Mayo cemetery on November 11th following the Remembrance Day Service. Councilors are invited to attend.
