i) CAO Report of Wednesday October 21, 2020

b) OCP and Zoning Amendment Bylaw

We received a letter from Minister Streicker dated October 13, 2020 as the official record of ministerial approval to proceed with third reading of our bylaw 339 for OCP/Zoning amendment. For Council's information. Dealt with previously.

c) WTP and Cold Water Well Update

The new cold water well is supposed to be drilled and capped in November.

As discussed at the September 30 meeting, we will have to use Village of Mayo reserve funds to pay for the backup propane boiler, heat exchanger, and engineering at the Mayo WTP. We are planning to enter into a reverse TPA with YG. YG will manage the project, engineering, contracts and installs and we'll pay for it. I have prepared a motion for Council's approval. Mayor Bolton recently had a conference call with Gareth Earl, YG Project Manager, and David Morrisette, Hydrologist for Morrison Hershfield, about the river undercutting the bank. Gareth was going to follow up with YG what can be done about this. Gareth sent an email update listing the steps he had to take to address this issue. For Council's information.

e) Landfill Update

Enclosed is an email from AYC regarding the landfill. YG will be hiring Dennis Shewfelt as project manager to work with the Municipalities on the various agreements (Regional, Liability, Lease). A separate facilitator will be hired for meetings.

Sperling Hanson, the independent engineer working on the landfill closure liability report on behalf of the municipalities is expected to provide the report and 3 D Imagery in November. For Council's information.
