TERMS AND CONDITIONS

GENERAL

- 1. Save and except as expressly authorized by the terms and conditions of this permit, the permit holder shall not dispose of solid waste in any manner that contravenes the Solid Waste Bylaw.
- 2. If any terms or conditions of this permit are found to be invalid, the remainder of this permit shall not be affected thereby.
- 3. Issuance of this permit shall not relieve the permit holder from liability arising from civil or criminal activities.
- 4. The issuance of this permit shall not be a defense against an enforcement action to halt or reduce production in order to maintain compliance with the terms and conditions of this permit.
- 5. By signing this permit, the permit holder authorizes the Public Works Manager or his authorized representative to, without prior notice and without incurring liability for so doing, inspect solid waste from outside Village boundaries at the entrance to the solid waste facility for the purpose of determining if the terms and conditions of this permit have been met.
- 6. All information submitted to the Public Works Manager shall be signed and certified by a principal executive officer of the permit holder who shall make the following certification:
 - "I certify that this document and all attachments were prepared under my direction or supervision and assure that qualified personnel properly gathered and evaluated the information submitted in accordance with the terms and conditions of the Solid Waste Bylaw. Based on my inquiry of the person or persons who manage the system, or those persons directly responsible for gathering the information, the information submitted is accurate and complete, to the best of my knowledge and belief."
- 7. Notwithstanding any terms or conditions of this permit, all provisions of the Solid Waste Bylaw, as amended from time to time, must be complied with by the permit holder at all times.
- 8. Any person who is responsible for solid waste generated by a person, business, industry or dump/landfill shall obtain a Permit to Dispose of Solid Waste prior to disposing of the solid waste in the Mayo landfill.
